- Definitions
 Seller' shall mean AGM Fasteners Pty Ltd, its successors and assigns or my person acting on behalf of and with the authority of AGM Fasteners 'ty Ltd.

 "Buyer' shall mean the Buyer (or any person acting on behalf of and with the authority of the Buyer) as described on any quotation, work authorisation or other form as provided by the Seller to the Buyer.

 "Guarantor" means that person (or persons) who agrees to be liable for the debts of the Buyer on a principal debtor basis.

 "Goods" shall mean all Goods supplied by the Seller to the Buyer (and where the context so permits shall include any supply of Services as hereinafter defined) and are as described on the invoices, quotation, work authorisation or any other forms as provided by the Seller to the Buyer.

 "Services" shall mean all Services supplied by the Seller to the Buyer and includes any advice or recommendations (and where the context so permits shall include any supply of Goods as defined above).

 "Price" shall mean the Price payable for the Goods as agreed between the Seller and the Buyer in accordance with clause 4 of this contract.

- The Commonwealth Trade Practices Act 1974 ("TPA") and Fair Trading Acts ("FTA")
 Nothing in this agreement is intended to have the effect of contracting out of any applicable provisions of the TPA or the FTA in each of the States and Territories of Australia (including any substitute to those Acts or reenactment thereof), except to the extent permitted by those Acts where applicable.

 Where the Buyer buys Goods as a consumer these terms and conditions shall be subject to any laws or legislation governing the rights of consumers and shall not affect the consumer's statutory rights.

- Acceptance
 Any instructions received by the Seller from the Buyer for the supply of Goods and/or the Buyer's acceptance of Goods supplied by the Seller shall constitute acceptance of the terms and conditions contained herein. Where more than one Buyer has entered into this agreement, the Buyers shall be jointly and severally liable for all payments of the Price.
 Upon acceptance of these terms and conditions by the Buyer the terms and conditions are binding and can only be amended with the written consent of the Seller.
 The Buyer shall give the Seller not less than fourteen (14) days prior written notice of any proposed change of ownership of the Buyer or any change in the Buyer's name and/or any other change in the Buyer's details (including but not limited to, changes in the Buyer's address, facsimile number, or business practice). The Buyer shall be liable for any loss incurred by the Seller as a result of the Buyer's failure to comply with this clause.

 Goods are supplied by the Seller only on the terms and conditions of trade herein to the exclusion of anything to the contrary in the terms of the Buyer's order notwithstanding that any such order is placed on terms that purport to override these terms and conditions of trade.

- Price and Payment
 At the Seller's sole discretion the Price shall be either:
 (a) as indicated on invoices provided by the Seller to the Buyer in respect of Goods supplied; or (b) the Seller's quoted Price (subject to clause 4.2) which shall be binding upon the Seller provided that the Buyer shall accept the Seller's quotation in writing within thirty (30) days.

 The Seller reserves the right to change the Price in the event of a variation to the Seller's quotation.

 Time for payment for the Goods shall be of the essence and will be stated on the invoice or any other forms. If no time is stated then payment shall be due thirty (30) days following the date of the invoice.

 Payment will be made by cash, or by cheque, or by bank cheque, or by credit card, or by direct credit, or by any other method as agreed to between the Buyer and the Seller.

 GST and other taxes and duties that may be applicable shall be added to the Price except when they are expressly included in the Price.

Delivery of Goods

- At the Seller's sole discretion delivery of the Goods shall take place when:
 (a) the Buyer takes possession of the Goods at the Seller's address; or
 (b) the Buyer takes possession of the Goods at the Buyer's nominated
 address (in the event that the Goods are delivered by the Seller or the address (in the event that the Goods are delivered by the Seller or the Seller's nominated carrier); or (c) the Buyer's nominated carrier takes possession of the Goods in which event the carrier shall be deemed to be the Buyer's agent.

 At the Seller's sole discretion the costs of delivery are:

 (a) in addition to the Price; or
- (a) in addition to the Price; or (b) for the Buyer's account.

 The Buyer shall make all arrangements necessary to take delivery of the Goods whenever they are tendered for delivery. In the event that the Buyer is unable to take delivery of the Goods as arranged then the Seller shall be entitled to charge a reasonable fee for redelivery. Delivery of the Goods to a third party nominated by the Buyer is deemed to be delivery to the Buyer for the purposes of this agreement.

 The failure of the Seller to deliver shall not entitle either party to treat this contrad as remudiated.

 The Seller shall not be liable for any loss or damage whatsoever due to failure by the Seller to deliver the Goods (or any of them) promptly or at all, where due to circumstances beyond the control of the Seller.

- Risk
 If the Seller retains ownership of the Goods nonetheless, all risk for the
 Goods passes to the Buyer on delivery.
 If any of the Goods are damaged or destroyed following delivery but prior
 to ownership passing to the Buyer, the Seller is entitled to receive all
 insurance proceeds payable for the Goods. The production of these terms
 and conditions by the Seller is sufficient evidence of the Seller's rights to
 receive the insurance proceeds without the need for any person dealing
 with the Seller to make further enquiries.
 Where the Buyer expressly requests the Seller to leave Goods outside the
 Seller's premises for collection or to deliver the Goods to an unattended
 location then such Goods shall be left at the Buyer's sole risk and it shall
 be the Buyer's responsibility to ensure the Goods are insured adequately

Upon such notice the rights of the Buyer to obtain ownership or any other interest in the Goods shall cease; and

 (c) the Seller shall have the right of stopping the Goods in transit whether or not delivery has been made; and

 (d) if the Buyer fails to return the Goods to the Seller then the Seller or the Seller's agent may (as the invitee of the Buyer) enter upon and into land and premises owned, occupied or used by the Buyer, or any premises where the Goods are situated and take possession of the Goods; and

 (e) the Buyer is only a bailee of the Goods and until such time as the Seller has received payment in full for the Goods then the Buyer shall hold any proceeds from the sale or disposal of the Goods, up to and including the amount the Buyer owes to the Seller for the Goods, on trust for the Seller; and

- (f) the Buyer shall not deal with the money of the Seller in any way which may be adverse to the Seller; and
 (g) the Buyer shall not charge the Goods in any way nor grant nor otherwise give any interest in the Goods while they remain the property of the Seller; and
 (h) the Seller can issue proceedings to recover the Price of the Goods sold notwithstanding that ownership of the Goods may not have passed to the Buyer; and
 (i) until such time that ownership in the Goods passes to the Buyer, if the Goods are converted into other products, the parties agree that the Seller will be the owner of the end products.

- Seller will be the owner of the end products.

 (a) constitute a security agreement for the purposes of the PPSA; and
 (b) create a security interest in.

 (ii) all Goods that will be supplied in the future by the Seller to the Buyer.

 The Buyer undertakes to:
 (a) promptly sign any further documents and/or provide any further information (such information to be complete, accurate and up-to-date in all respects) which the Seller may reasonably require to:

 - (ii) register any other document required to be registered by the PPSA; or (iii) correct a defect in a statement referred to in clause 8.3(a)(i) or
- (iii) correct a defect in a statement referred to in clause 8.3(a)(i) or 8.3(a)(ii); indemify, and upon demand reimburse, the Seller for all expenses incurred in registering a financing statement or financing change statement on the Personal Property Secutities Register established by the PPSA or releasing any Goods charged thereby; not register a financing change statement in respect of a security interest without the prior written consent of the Seller; not register, or permit to be registered, a financing statement or a financing change statement in relation to the Goods in favour of a third party without the prior written consent of the Seller; and immediately advise the Seller of any material change in its business practices of selling the Goods which would result in a change in the nature of proceeds derived from such sales.  The Seller and the Buyer agree that sections 96, 115 and 125 of the PPSA do not apply to the security agreement created by these terms and conditions.

 The Buyer hereby waives its rights to receive notices under sections 95, 118, 121(4), 130, 132(3)(d) and 132(4) of the PPSA.
 The Buyer waives its rights as a grantor and/or a debtor under sections 142 and 143 of the PPSA.

 Unless otherwise agreed to in writing by the Seller, the Buyer waives its right to receive a verification statement in accordance with section 157 of
- the PPSA.

 The Buyer shall unconditionally ratify any actions taken by the Seller under clauses 8.3 to 8.5. 8.8

- Security and Charge
 Despite anything to the contrary contained herein or any other rights which the Seller may have howscover:
 (a) where the Buyer and/or the Guarantor (if any) is the owner of land, realty or any other asset capable of being charged, both the Buyer and/or the Guarantor agree to mortgage and/or charge all of their joint and/or several interest in the said land, realty or any other asset to the Seller or the Seller's nominee to secure all amounts and other monetary obligations payable under these terms and conditions. The Buyer and/or the Guarantor acknowledge and agree that the Seller or the Seller's nominee) shall be entitled to lodge where appropriate a caveat, which caveat shall be withdrawn once all payments and other monetary obligations payable hereunder have been met.
 - caveat, which caveat shall be withdrawn once all payments and other monetary obligations payable hereunder have been met. should the Seller elect to proceed in any manner in accordance with this clause and/or its sub-clauses, the Buyer and/or Guarantor shall indemnify the Seller from and against all the Seller's costs and disbursements including legal costs on a solicitor and own client basis.

 (c) the Buyer and/or the Guarantor (if any) agree to irrevocably nominate constitute and appoint the Seller or the Seller's nominee as the Buyer's and/or Guarantor's true and lawful attorney to perform all necessary acts to give effect to the provisions of this clause 9.1.

Defects
The Buyer shall inspect the Goods on delivery and shall within one (1) day of delivery (time being of the essence) notify the Seller of any alleged defect, shortage in quantity, damage or failure to comply with the description or quote. The Buyer shall afford the Seller an opportunity to inspect the Goods within a reasonable time following delivery if the Buyer shall fall to comply with these provisions the Goods shall be presumed to be free from any defect or damage. For defective Goods, which the Seller has agreed in writing that the Buyer is entitled to reject, the Seller's liability is limited to either (at the Seller's discretion) replacing the Goods or repairing the Goods except where the Buyer has acquired Goods as a consumer within the meaning of the Trade Practices Act 1974 (OWIth) or the Fair Trading Acts of the relevant state or territories of Australia, and is therefore also entitled to, at the consumer's discretion either a refund of the purchase price of the Goods, or repair of the Goods, or replacement of the Goods.

Returns

- Returns will only be accepted provided that:

 (a) the Buyer has complied with the provisions of clause 10.1; and

 (b) the Seller has agreed in writing to accept the return of the Goods; and

 (c) the Goods are returned at the Buyer's cost within seven (7) days of
- the delivery date; and
 (d) the Seller will not be liable for Goods which have not been stored or
- (a) the Seller will not be liable for Goods which have not been stored or used in a proper manner; and
 (e) the Goods are returned in the condition in which they were delivered and with all packaging material, brochures and instruction material in as new condition as is reasonably possible in the circumstances.

 The Seller may (at their sole discretion) accept the return of Goods for credit but this may incur a handling fee of up to twenty percent (20%) of the value of the returned Goods plus any freight costs.

Warranty
For Goods not manufactured by the Seller, the warranty shall be the
current warranty provided by the manufacturer of the Goods. The Seller
shall not be bound by nor be responsible for any term, condition,
representation or warranty other than that which is given by the
manufacturer of the Goods.

- Default and Consequences of Default
 Interest on overdue invoices shall accrue daily from the date when
 payment becomes due, until the date of payment, at a rate of two and a half percent (2.5%) per calendar month (and at the Seller's sole discretion such interest shall compound monthly at such a rate) after as well as
- such interest shall compound monthly at such a rate) atter as well as before any judgment. In the event that the Buyer's payment is dishonoured for any reason the Buyer shall be liable for any dishonour fees incurred by the Seller. If the Buyer defaults in payment of any invoice when due, the Buyer shall indemnify the Seller from and against all costs and disbursements incurred by the Seller in pursuing the debt including legal costs on a solicitor and own client basis and the Seller's collection agency costs. Without prejudice to any other remedies the Seller may have, if at any time the Buyer is in breach of any obligation (including those relating to

- payment) the Seller may suspend or terminate that supply of Goods to the Buyer and any of its other obligations under the terms and cond''ons. The Seller will not be liable to the Buyer for any loss or damage the Buyer suffers because the Seller has exercised its rights under this clause. If any account remains overdue after thirty (30) days then an amount of the greater of twenty dollars (\$20.00) or ten percent (10%) of the amount overdue (up to a maximum of two hundred dollars (\$20.00)) shall be levied for administration fees which sum shall become immediately due

 Without prejudice to the Seller's other remedies at law the Seller shall be entitled to cancel all or any part of any order of the Buyer which remains unfuffilled and all amounts owing to the Seller shall, whether or not due for payment, become immediately payable in the event that:

 (a) any money payable to the Seller becomes overdue, or in the Seller's opinion the Buyer will be unable to meet its payments as they fall due;

 (b) the Buyer becomes insolvent, convenes a meeting with its creditors or
 proposes or enters into an arrangement with creditors, or makes an
 assignment for the benefit of its creditors; or
 (c) a receiver, manager, liquidator (provisional or otherwise) or similar
 person is appointed in respect of the Buyer or any asset of the Buyer.

- Cancellation
 The Seller may cancel any contract to which these terms and conditions apply or cancel delivery of Goods at any time before the Goods are delivered by giving written notice to the Buyer. On giving such notice the Seller shall repay to the Buyer any sums paid in respect of the Price. The Seller shall not be liable for any loss or damage whatsoever arising from
- Seller shall not be liable for any loss or damage whatsoever anising norm such cancellation.

 In the event that the Buyer cancels delivery of Goods the Buyer shall be liable for any loss incurred by the Seller (including, but not limited to, any loss of profits) up to the time of cancellation.

 The Buyer consents to the Seller being given a consumer credit report to collect overdue payment on commercial credit (Section 18K(1)(h) Privacy Act 1988.

 (e) enabling the daily operation of Buyer's account and/or the collection of amounts outstanding in the Buyer's account in relation to the Goods.
 The Seller may give information about the Buyer to a credit reporting agency for the following purposes:
 (a) to obtain a consumer credit report about the Buyer;

 (c) advice that the Seller is a current credit provider to the Buyer;
 (d) advice of any overdue accounts, loan repayments, and/or any outstanding monies owing which are overdue by more than sixty (60) days, and for which debt collection action has been started;
 (e) that the Buyer's overdue accounts, loan repayments and/or any outstanding monies are no longer overdue in respect of any default that has been listed;
- outstanding monles are no longer overtue in respect of any detail that has been listed;

 (f) information that, in the opinion of the Seller, the Buyer has committed a serious credit infringement (that is, fraudulently or shown an intention not to comply with the Buyers credit obligations);

 (g) advice that cheques drawn by the Buyer for one hundred dollars (\$100) or more, have been dishonoured more than once;

 (h) that credit provided to the Buyer by the Seller has been paid or otherwise discharged.

- Unpaid Seller's Rights

 Where the Buyer has left any item with the Seller for repair, modification, exchange or for the Seller to perform any other Service in relation to the item and the Seller has not received or been tendered the whole of the Price, or the payment has been dishonoured, the Seller shall have:

 (a) a lien on the Item;
 (b) the right to retain the item for the Price while the Seller is in possession of the item;
 (c) a right to sell the item.

 The lien of the Seller shall continue despite the commencement of proceedings, or judgment for the Price having been obtained.

 17.6 The Buyer shall not be entitled to set off against, or deduct from the Price, any sums owed or claimed to be owed to the Buyer by the Seller nor to withhold payment of any invoice because part of that invoice is in dispute.
 17.7 The Seller may license or sub-contract all or any part of its rights and obligations without the Buyer's consent.
 17.8 The Buyer agrees that the Seller may review these terms and conditions at any time. If, following any such review, there is to be any change to these terms and conditions, then that change will take effect from the date on which the Seller notifies the Buyer of such changes. The Buyer shall be under no obligation to accept such changes except where the Seller supplies further Goods to the Buyer and the Buyer accepts such Goods.
 17.9 Neither party shall be liable for any default due to any act of God, war, terrorism, strike, lock-out, industrial action, fire, flood, storm or other event beyond the reasonable control of either party.</
